Application for Award

This award is designed to recognize leadership by a young REALTOR® or an affiliate professional that is making a difference as a member or an affiliate of the Fredericksburg Area Association of REALTOR® and in their community.

Young is defined as being new (under 7 years) in the real estate profession or affiliate profession, and/or being under the age of 45, and/or a person who is advancing and promoting the education and involvement of the young professional (as defined above).

Please complete the following application and return to FAAR before January 27, 2012. Your total points, marked in the spaces in the left column, must be a minimum of 90 points to qualify for nomination for the award. The nominees will be judged on having the required minimum point total of 90 points and a short essay about the nominee's leadership skills. The Award will not necessarily be a yearly award.

PLEASE NOTE:

- 1) To qualify, applicant must meet the minimum points in all categories.**

All activities must occur between January 1, 2011 and December 31, 2011 (with the exception of the designations held). Production achievement is awarded as a point per \$100,000 or production for the calendar year (minimum of \$1.5 million or 15 transaction sides)

Non-producing Assistant Brokers – 20 points
Producing Brokers/ Associate Brokers/ Managers – 10 points
Affiliate Members – 30 points
